LETTER FROM OUR CHAIR & PRESIDENT

Dear Friends of Resolution,

The world needs responsible leaders to address the many challenges facing the global community in the twenty-first century. Young people around the world are stepping forward to make a change today. Students are more globally connected through social media and other forms of communication, more socially conscious, and more dedicated to changing the world than ever before.

Since 2007, The Resolution Project has been providing some of these dedicated young leaders with Resolution Fellowships to help them start socially-responsible ventures and begin making positive impact today. Through this formative and empowering experience with social entrepreneurship, we are developing a generation of leaders with a lifelong commitment to social responsibility.

In 2011, Resolution made great progress toward these important objectives, and we are proud to report to you some of the highlights from the past 12 months.

- In March 2011, Resolution welcomed nine new Fellows into the Resolution community at its 3rd Annual Social Venture Challenge (“SVC”) at the Harvard World Model United Nations conference in Singapore. We look forward to continuing to build on this success in 2012 when we plan to add new SVC partners.
- Resolution’s Board, Advisory Board, Leadership Council, and other volunteer groups continued to impact our organization and the lives of our Fellows. It is both gratifying and impressive that all of Resolution’s success to date has been powered by volunteers.
- We are extraordinarily grateful for your partnership and support in 2011. We were able to increase our fundraising capacity by more than 70% over 2010. This support and growth will allow us to launch new SVCs, select new Fellows, open our first office, and hire our first full-time staff member in 2012.
- We have developed a successful BETA of our cutting-edge web platform for the

Resolution Fellows and other aspiring social entrepreneurs. We hope to launch this platform in 2012, after spending most of 2011 creating this unique set of tools for our young leaders.

“ShareHealth!” – Heidelberg, Germany

Objective: Improve oral hygiene in the Ukraine and Ecuador through peer education videos and delivery of dental supplies.

During their studies, fellows on the ShareHealth! team were moved by the World Health Organization’s statistic that the average 12 year old in Ukraine and Ecuador has at least 4 bad permanent teeth.

Rima discussed the poor state of oral health in much of the world with The Resolution Project: “the developed world is blessed with high levels of healthcare as well as education and awareness around this issue; however, there are still major problems concerning dental care in Eastern Europe and South America where oral hygiene is underestimated as an asset to health.”

The ShareHealth! team aims to improve the oral hygiene of Ukrainian and Ecuadorian children by collaborating with an elementary school in Heidelberg to produce an educational video narrated by children and dubbed into the local language. In the video, they share basic preventative dental techniques to build long-term oral health habits.

Working with a school in Ecuador and an orphanage in Ukraine, the children also form a class-to-class bond and will send dental supplies donated by the Heidelberg community to help their partner organizations put the video into action.

Vidit Aatrey, India Institute of Technology Class of 2012

Prashant Kumar, India Institute of Technology Class of 2012

“Pledge” – New Delhi, India

Objective: Connect underprivileged youth, who are training with NGOs, to potential employers through a web portal.

Vidit and Prashant saw that NGOs in India have experienced a decrease in the participation of underprivileged students in training programs over the past few years, due to the inability of these NGOs to find employment for these students. They believe this situation arises due to the absence of specialist placement programs at these NGOs.

Vidit said, “In a country with a high percentage of youth, channeling their talents in the right direction is a must for our country’s progress. Pledge tries to provide that channel to the underprivileged youth, who have been consistently neglected otherwise.”

Their team of IIT Delhi engineering undergraduates are setting up a web

portal to provide employment opportunities to youth studying in NGOs. This platform will allow the companies to view the students’ profiles and, if interested, set up placement interviews.

Empowering Women in the Atlas – Adghagh, Morocco

Objective: Address both the public health issue of personal hygiene and women’s rights issues by constructing a bathhouse, in which the community can bathe and women can socialize and participate in the local economy.

While on exchange at Sciences-Po Paris, Lamia shared with Taylor the findings from her participatory development research from a trip to Adghagh in the Middle Atlas Mountains: the women there felt a *hammam*, a bathhouse, would move their community, their families and their lives forward significantly. In a region where drinking water is scarce and bathing water is even scarcer, the public health impact of such a facility would be significant. A *hammam* is also one of the few socially-acceptable spheres in which Muslim women can freely move and even work in a conservative community, empowering the women both economically and socially to become larger stakeholders in the community.

Lamia said, “This project embodies the power of citizens. As a young Moroccan woman, I do not expect everything from the state; I, rather, believe that every single citizen can have a positive impact on society. The value of the *hammam* in this village will go beyond improving the community’s conditions of life, it re-asserts the value of women as the basis of society. It also takes the feeling of marginalization away from the community, by showing that there are people who care for their needs.”

Lamia and Taylor have visited the village and met with its leaders, who

have enthusiastically embraced the plan. They are in discussions with the local government for a land grant and will shortly be commissioning engineering and architectural plans. Simultaneously they are beginning to fundraise for the construction of the facility.

Samuel Baker, Monash University Class of 2012

Shanthakumar Bannirchelvam, Sydney University, Class of 2014

Global Health Solutions (GHS) – Melbourne, Australia

Objective: Increase the life expectancy of Australia’s indigenous population by providing SMS health information specifically targeting substance abuse and maternal health.

Shanthakumar and Samuel were inspired by 2010 Resolution Fellow Shaan Gandhi’s Health2Home venture. They built on Shaan’s work in Uganda, applying the same SMS-delivery technology (Frontline SMS) through an innovative use of the Ushahidi Platform to crowd-source the most relevant topics to address based on geography and chatter. The collaboration between Shan and Shaan has been another great success story of our robust network of Fellows and mentors and a trend we continue to foster.

Shan said, “The Resolution Project reminds me that we are not alone in striving to improve the world and that we are always a phone call or email away from the mentors and support we need to make things happen. Most importantly, it has instilled the conviction that people around the world, regardless of cultural and geographical differences, believe in the power of youth to make a difference.”

Shan, Samuel and their team of physicians plan to broadcast appropriate text messages to indigenous communities using this technology. GHS is currently focused on gaining acceptance from the elders of the indigenous population and identifying local collaborators in the existing aboriginal healthcare service.

Indian Monsoons – Bangalore, India

Bore well designed to channel collected monsoon rainwater back into the Bangalore aquifer.

About Dheer

Dheer Bhatnagar is 21 years old and currently studying law at the National Law School of India University. Dheer is implementing rainwater harvesting systems across the city of Bangalore with Resolution Fellows, Surbhi Kuwelkar and Aditya Kumar. Traditionally dependent on water from rivers for their needs, over a billion Indians are now facing increasing water shortages caused by global warming and irresponsible water use. Bangalore, with a population of over nine million, shares these woes. Dheer, Aditya and Surbhi began implementing rainwater harvesting systems in Bangalore last year, and they are currently leading these efforts both on the university campus and across the city. Dheer says: “Students can make a difference on their environment. At Indian Monsoons, we are saving rains for a rainy day.”

About Indian Monsoons

Objective: Install catch basin systems to replenish the water table with the monsoon rains.

The Indian Monsoons team is working to replenish the water table in Bangalore using techniques that have proven very successful in New Delhi. Groundwater is polluted and diminishing, making it difficult to reach water, even with expensive and deep bore wells. Urbanization means that the runoff from the very wet monsoon season no longer seeps naturally through the earth to the water table. The solution is to install catch basins on the roofs of buildings and bore wells just a few feet under the concrete to reinject the natural monsoon water into the water table.

Dheer, Aditya and Surbhi have been using their own 25-acre university campus as a test area. After securing support from the University, Dheer and his team commissioned an engineering review and assessed various proposals for the campus. In advance of the 2011 monsoon season, three independent systems were installed on campus, capturing and purifying over 40,000 liters of water. The team is in the process of expanding the project across campus and into Bangalore.

UPDATES FROM THE FIELD

Carlos Garcia

Green Garbage – Caracas, Venezuela

Carlos Garcia and his *Clorofila* (Green Garbage) venture team had a productive 2011, becoming the first Resolution team to successfully complete their initial pilot venture. In 2009, as a member of the inaugural class of Resolution Fellows, Carlos set out to create a garbage recycling program—the first of its kind—on his university campus, Universidad Central de Venezuela. Carlos then extended the reach of his pilot project into several local elementary schools, teaching about recycling to young students who were learning about sustainability for the first time and taking that knowledge home to their families. Throughout this time, Carlos never lost sight of his long-term vision to build the first garbage separation plant in Venezuela. In many meetings with local senior officials, Carlos has also achieved political buy-in for his goal, including the tentative selection of a plot of land for the future facility. Carlos spent much of 2011 consolidating the success of these initial activities and focusing on graduating from UCV. He also successfully incorporated Clorofila as a non-profit in Venezuela. Carlos has big plans for 2012 and beyond, initiating the long and complex process of due diligence and fundraising for his recycling plant—a game-changing piece of infrastructure for his home country and an example for the region.

Nick Fiore & Alex Merkovic

IT Empowerment – Byimana, Rwanda

During 2011, Alex was working in Rwanda for the United Nations World

Food Programme, which has embedded him with the Rwandan government as a Special Assistant to the Minister for Gender and Family Promotion. Nick has been lecturing on international development at Florida State University and was able to attend Resolve 2011 in October, sharing with the attendees his experience as a Resolution Fellow and the work that he and Alex are doing in Rwanda. Nick plans to spend the summer of 2012 in Rwanda working with Alex on IT Empowerment, which continues to train teachers and students in Bukomero primary school. Alex and Nick have been working with IT Empowerment's paid employee, Akimana Ernest, to evaluate and prioritize the program's needs ahead of a major expansion in the school's curriculum next year.

Jessica Haeussler & Mauro Trujano

Unidas – Accra, Ghana

During 2011, Jessica and Mauro were working in Ghana on Unidas, the organization they started to empower victims of gender-based violence by providing these women microfinance and business education. They partnered with a women's shelter and conducted trainings with the staff at the shelter, teaching them microfinance strategies. They were also in the process of establishing partnerships with local microfinance institutions. When the team encountered visa issues, they chose to move operations to Germany. Jessica is now based in Frankfurt and Mauro will join her there shortly. The team has been working on an exciting model for their new location in Frankfurt, and will be working on their new concept in 2012.

Shaan Gandhi

Health2Home – Lira Province, Uganda

Shaan is a second year student at Harvard Medical School in Boston, Massachusetts. In 2009 he mobilized a team of dedicated individuals from across the United States and United Kingdom who have become the social entrepreneurs responsible for Health2Home. Health2Home's goal is to leverage text messaging technology to improve access to maternal and child health care services in rural Uganda. The team recently completed a needs assessment and demographic survey of 300 families across four villages in Lira, Uganda. They collected data on mobile phone market penetration, text messaging costs and data access. The team also studied community utilization of existing health clinics in Lira. Discussions with villagers highlighted the pressing need for access to perinatal and infant care, and the high penetration of cell phone (but not yet computer) technology in rural communities. Empowered by their findings, Shaan and his team plan to establish a text messaging system that will effectively deliver health information to the people of Lira starting in 2012.

Betsy Graves & Dan Cahill

Making the Most of Water – Nyanza Province, Kenya

In June 2011, Betsy graduated from the University of Virginia with a Bachelor's degree in Foreign Affairs and English Literature (Modern Studies Program). She moved to Kenya in July and has been working on constitutional civic education initiatives through the Caucus for Wom-

en's Leadership in preparation for Kenya's national election in 2012. Dan graduated from the United States Coast Guard Academy and has been posted aboard the USCG cutter Elm based in Atlantic Beach, North Carolina. Betsy, Dan, and their team are currently analyzing the first full year's worth of data from the pilot program that Making the Most of Water developed in 2010. Initial indications suggest that the pilot program was a huge success with crop yields increasing dramatically on the irrigated plots, which produced an average of more than \$190 of profit per 3-month growing season per kit. This suggests that the kits produce a full return on investment in two to three seasons, and even a limited application of the technology could have a significant impact on the quality of life of farmers in Kenya, where the World Bank estimates that the average income in 2010 was just \$790 per annum. Betsy and her team are now developing a strategy to expand access to the kits in response to the significant community demand.

UPDATE ON OUR INNOVATIVE WEB PLATFORM

Resolution's online platform originated in 2007 with the vision of providing Resolution Fellows with a collaborative digital forum to enable cooperation among our Fellows, mentors and supporters. Every year since then, the platform has successfully powered our Social Venture Challenge ("SVC") at WorldMUN where we select our annual class of new Resolution Fellows.

The next generation of the platform is set to launch in 2012. It is a forum where Resolution Fellows will share ideas and best practices with, and seek advice and assistance from one another.

We expect that the online platform and its community of members will continue to expand as a vibrant environment for young social entrepreneurs to:

- create, share and explore social ventures, resources, opportunities and best practices related to social entrepreneurship;
- build their own projects and activate others or find a project to support;
- seek community advice through mentors and polls; and
- plan digital and face-to-face events.

FEATURED VOLUNTEERS

Dr. Prabhjot Singh, M.D., Ph.D., Resolution Advisory Board Director of Systems Design, The Earth Institute, Columbia University

Dr. Singh is exactly why Resolution formed an Advisory Board. His credentials cannot encapsulate the phenomenal energy he brings to everything in his life, from his clinical medical work to his groundbreaking leadership in the Millennium Villages program at the Earth Institute. Whether in his prior work at the International Rescue Committee or as Chair of the technical task force for national scale-up of Community Health Workers across the Millennium Villages, Dr. Singh brings an unusual combination of action, thoughtfulness, kindness, and leadership that translates into impact. For Resolution, Dr. Singh has advised the Board on key questions of international project work, and spoken with Resolution Fellows about their work on the ground. Dr. Singh even took Resolution Fellow Shaan Gandhi, of Health2Home, to a conference on technology-enabled medicine in developing countries, which was a highlight of Shaan's first year as a Resolution Fellow. Dr. Singh has also helped bridge partnership discussions between Resolution and the world-renowned Earth Institute at Columbia University. Whenever Resolution has needed him, Dr. Singh has been there to advise Resolution on both strategy and tactics. We are most fortunate to have his advice, and lucky that his skills and experience come to us in the context of such a positive, welcoming, and genuine leader in social entrepreneurship, global health, and sustainable development.

Ariel Dora Stern, Resolution Leadership Council Project Manager, LeapFrog Investments / Ph.D. Candidate, Harvard University

Ariel is a doctoral candidate at Harvard University and a long-time consultant to LeapFrog Investments, the world's first and largest investor in companies that insure under-served people in Africa and Asia. Ariel's academic research focuses on inequality and health in minority populations and developing countries, productivity in healthcare, healthcare technology adoption and the economics of entrepreneurship. Ariel studied economics at Dartmouth College, Oxford University and the Free University of Berlin and is currently a National Bureau of Economic Research Fellow in Aging and Health Economics and a fellow of the Harvard Multidisciplinary Program in Inequality and Social Policy. Ariel is a two-time U.S. national collegiate figure skating champion.

Ariel attended and judged Resolution's first Social Venture Challenge. The energy and quality of the participants left Ariel not only impressed with, but also convinced of the value of expanding the program and The Resolution Project's vision of building a global community of young social entrepreneurs. As an RLC member, Ariel has been leading the six-person Metrics and Measurement working group, which is building a standardized, Internet-based method for Resolution's mentor teams to track their communications with fellows and proactively provide assistance and support to ventures. The group is also automating all of Resolution's Fellow reporting practices to make the process of semi-annual reporting as seamless as possible for fellows. The automated online reporting tool will also allow Fellows to identify needs prospectively and track and articulate their goal-setting. In acknowledgement of her invaluable leadership on these and other projects, Ariel was asked to join Resolution's Board of Directors in early 2012 and currently serves as Vice Chair. Having served as an SVC judge, an RLC member, and Vice Chair of the Board of Directors, Ariel has

given Resolution her time, expertise, and boundless energy, and helped shape the organization from its earliest successes.

Kelsey Overby, Director of Events Account Executive, Mr. Youth

Kelsey Overby is an Account Executive at Mr. Youth, a social media agency in New York City. In her current position, she works with clients including Procter & Gamble, American Express, and Clorox on projects ranging from Facebook application builds to blogger programs to runway show production. Kelsey is a 2009 graduate of the University of Washington.

Kelsey has been involved with The Resolution Project since 2009, when she helped staff the first Social Venture Challenge (SVC) in The Hague, Netherlands. In 2010, she traveled as a member of the Resolution team to again assist with the SVC, and submitted a proposal for Resolution's first fundraiser, Resolve 2010, which took place that fall and raised approximately \$70,000. As Event Chair and now Volunteer Director of Events, Kelsey has planned and managed: Resolve 2010, Resolution's first NYC fundraising gala; Resolution Summer Social 2010, an event that provided an opportunity for young professionals to get involved with the organization; and Resolve 2011, Resolution's second NYC fundraising gala, which attracted more than 250 attendees and raised more than \$100,000. Kelsey is currently planning various fundraising events for Resolution in 2012. Her hard work, dedication, and leadership have been integral to Resolution's early success with events, and Resolution is thankful for her tremendous generosity with her time and for her efforts on its behalf.



Eric Hatzimemos

Resolution has been able to count on the phenomenal support of Eric Hatzimemos since its inception in 2007. Eric’s first gift to Resolution helped significantly fund the very first Social Venture Challenge in The Hague in 2009. Eric’s personal story is one in which service to the public and helping people play central roles. A lawyer by training, Eric served as an Assistant District Attorney in Brooklyn, New York for over four years at the outset of his career. Set apart by his flawless record of success and his unstinting hard work and dedication, Eric rose to the attention of then-Mayor of New York, Rudolph W. Giuliani. Mayor Giuliani asked Eric to serve, first as Assistant Commissioner for Criminal Justice, then as one of the three counsels to the Mayor himself in City Hall. Eric played a central role in the astounding rebirth of New York City in the

1990s, overseeing budgets for the fire and police departments and chairing the board of the over \$100 billion city employee pension. 
