## **REASONABLE CAUSE FOR LATE FILING STATEMENT**

The Resolution Project, Inc. (the “Taxpayer”) respectfully submits this statement to request that the IRS not assess any late filing penalties for our June 30, 2024 (FY 2023) Form 990, which is being filed after the original due date.

The Taxpayer’s prior accounting firm had experienced significant turnover over the course of our engagement which led to disruptions in continuity and a loss of institutional knowledge, which caused delays in the completion of the FY 2023 financial statements. Additionally, the Taxpayer began the process of integrating another nonprofit in late 2023 to keep the other nonprofit from failing; this introduced additional complexities that delayed financial integration but allowed the programs to continue. These challenges made it difficult to maintain consistent oversight and timely financial reporting, ultimately impacting the ability to file Form 990 on time.

While many of these changes occurred over an extended period, the cumulative effect significantly hindered our ability to meet the filing deadline.

The Taxpayer has engaged with new experienced professionals and has enhanced our timeline management processes to ensure that financial audits and related filings are completed in advance of deadlines.

The Taxpayer has historically been compliant in its tax obligations, having never been assessed a late penalty. The Taxpayer has acted prudently by engaging a new, nationally recognized, professional audit and tax preparer firm to service them. The Taxpayer’s failure to file on time was neither willful nor neglectful; we exercised ordinary business care and prudence. We respectfully request that any penalties be waived due to the reasonable cause outlined above.

As a public charity under IRC § 501(c)(3), penalties would cause extreme financial hardship and diminish resources needed to fund programs that provide support and resources to promising young social entrepreneurs.

We believe the Taxpayer has met the reasonable cause requirements under Treasury Regulation § 301.6652-1(f), IRM 20.1.1.3.2.1, and IRM 20.1.1.3.2.2. therefore, no penalty should apply.
